

(MBA PROGRAMME), OTHAKKALMANDAPAM VILLAGE MAYILERIPALAYAM POST COIMBATORE, TAMIL NADU - 641032, for the academic year 2002-2003, for course(s) and intake as given below with specific condition that admission shall be made through the Central Counseling by the Government of TAMIL NADU only.
