

The Management should submit a duly signed undertaking on a Rs.20/ non-judicial stamp paper to the Registrar, Anna University of Technology, Coimbatore 641 047, within 15 days from the date of receipt of this letter to the effect that the conditions specified above will be fulfilled.

**Note :** If at any point of time during an inspection or surprise inspection it is found that the norms and standards prescribed are not maintained by the college the provisional affiliation granted above will be withdrawn without any notice.
